## 2018 Central Coast Liberty Luncheon

As reported by our local news media, the Monterey Peninsula Republican Women Federated organization will host an event at the PCRP's Fiesta Banquet Room. Maricopa County, Arizona's former Sheriff, Joe Arpaio will be one of four guest speakers scheduled to present perspectives on Immigration Reform and other topics.

Several conditions ran with TPL's transfer of the Rancho Canada parcels to MPRPD – one of which established that MPRPD will not interfere with Wedgewood's lawful use of their leased portions of said property. MPRWF, Wedgewood's client for more than a decade, has previously invited guest speakers to present on various topics. Staff has been working with the Monterey County Sheriff's Office (SO), the SO's and MPRPD's respective Legal Counsel, and Wedgewood, as necessary.

The Trust for Public Land, Santa Lucia Conservancy, Trout Unlimited, and MPRPD have joined forces to plan, coordinate and implement a dedication ceremony for MPRPD's recently acquired Rancho Canada Unit at Palo Corona Regional Park. 2018 Central Coast Liberty Luncheon: To date, Staff has been informed that costs associated with the September 13, 2018 event may be corporately borne by Wedgewood, MPRWF, and others. MPRPD's Staff will assist with the event. MPRPD's Staff time, equipment-use, and infrastructure-related costs will be calculated and absorbed. Staff will seek reimbursement for all other costs, including, but without limit, expenditures to install and remove temporary security fence and barriers, obtaining site security, and costs for the repair or replacement of items damaged or lost due to this event. The Board will be informed regarding these estimated costs and their recovery at a future Board meeting.

Rancho Canada Community Celebration: TPL is taking the lead for this celebration's planning, coordination and execution. The Rancho Canada Golf Course' acquisition partners, comprised of The Trust for Public Land, Santa Lucia Conservancy, Trout Unlimited and MPRPD, have contributed staff time for this planned event. MPRPD may elect to expend a nominal amount of funding, if and as needed, to enhance the program. This amount has yet to be determined but expenditures will comply with MPRPD's Budget Policy.
